REVIEW

The Idaho State Athletic Commission, by and through Lewis N. Stoddard, Commissioner, in his official capacity, and the Idaho Division of Occupational and Professional Licenses, Russell Barron, Administrator, in his official capacity, by and through their attorneys of record, Elam & Burke, P.A., seek to invoke the original declaratory and Writ of Mandamus

jurisdiction of the Idaho Supreme Court, and hereby allege, aver, and complain against the above-named Respondent as follows:

INTRODUCTION

- 1. This year, the Idaho legislature passed House Bill 206, which amended certain provisions of the Idaho Administrative Procedure Act ("IDAPA"), Idaho Code sections 67-5201-92. H.B. 206.
- 2. The amendments went into effect on July 1, 2023. The effect of the amendments was to expand legislative oversight of administrative agency rulemaking. The statute prevents administrative agencies from promulgating and adopting enforceable administrative rules until those rules have been pre-approved by concurrent resolution of the legislature.
- 3. Before July 1, 2023, the law prohibited administrative agencies from adopting enforceable administrative rules that impose fees ("Fee Rules") until those Fee Rules have been pre-approved by concurrent resolution of the legislature. I.C. § 67-5224(5) (as of June 30, 2023). As of July 1, 2023, the law now imposes the same legislative pre-approval requirement on all administrative rules in Idaho.
- 4. The Idaho State Athletic Commission and the Idaho Division of Occupational and Professional Licenses bring this original action seeking the Court's review of those portions of the IDAPA that provide for legislative pre-approval of draft administrative rules before those rules may become final, enforceable, and in effect ("Legislative Pre-Approval"). Petitioners contend that Legislative Pre-Approval is unconstitutional in violation of Article II, Section I, Article III, Sections 1, 15, and 29, and Article IV, Section 10 of the Idaho Constitution. Petitioners ask this Court to review the Legislative Pre-Approval provisions of the IDAPA, declare Legislative Pre-Approval of administrative rules unconstitutional, and issue a Writ of

Mandamus to Respondent to publish the State Athletic Commission's 2023 rule chapter in the Idaho Administrative Code thereby allowing them to become final, enforceable and in effect.

5. For the reasons set forth in more detail in Petitioners' Motion to Expedite Under I.A.R. 5 and 44 filed concurrently herewith, Petitioners respectfully ask that the Court expedite this time sensitive matter because Petitioner Idaho State Athletic Commission is currently operating without final, enforceable rules; Petitioners will begin drafting administrative rules in November and December of 2023 which must then be submitted to the legislature so that the Legislative Pre-Approval process can proceed; and to provide certainty to all parties involved in the administrative rulemaking process for the upcoming Legislative Session slated to begin on January 8, 2024. Declaration of Russel Barron in support of Verified Petition ("Barron Decl.") ¶

PARTIES

- 6. Lewis N. Stoddard, in his official capacity, is the Commissioner of Petitioner Idaho State Athletic Commission. The Idaho State Athletic Commission is an agency of the executive branch of the Idaho government, established by Idaho Code section 54-401, and is vested with the power and duty to adopt rules to "direct, supervise and control all amateur and professional contests and exhibitions within the state." I.C. § 54-406; Barron Decl. ¶ 3.
- 7. Russell Barron, in his official capacity, is the Administrator of Petitioner Idaho Division of Occupational and Professional Licenses, an executive branch agency. Barron Decl. ¶1. The Idaho State Athletic Commission is one of many administrative agencies under the umbrella of the Idaho Division of Occupation and Professional Licenses, which "provides consumer protection and public safety through its regulation of more than 204,000 licenses

within more than 48 Boards and Commissions" in Idaho, including the State Athletic Commission. Barron Decl. ¶ 2.

8. Respondent Brad Hunt, in his official capacity, is the Administrative Rules Coordinator ("Rules Coordinator") of the Office of the Administrative Rules Coordinator. Barron Decl. ¶ 5. The Office of the Administrative Rules Coordinator is established within the Division of Financial Management pursuant to Idaho Code section 67-5202 and has the statutory duty to publish administrative rules promulgated according to the requirements of the IDAPA in the Idaho Administrative Code. I.C. § 67-5204.

JURISDICTION AND VENUE

- 9. This Court has original jurisdiction to declare a statute unconstitutional. *Mead v. Arnell*, 117 Idaho 660, 663, 791 P.2d 410, 413 (1990); *Ybarra v. Legislature by Bedke*, 166 Idaho 902, 906, 466 P.3d 421, 425 (2020).
- 10. This Court has "original jurisdiction to issue writs of mandamus, certiorari, prohibition, and habeas corpus, and all writs necessary or proper to the complete exercise of its appellate jurisdiction." IDAHO CONST. art. 5, § 9; I.C. § 1-203; I.A.R. 5(a).
- 11. Venue is proper under Idaho Code § 1-208 and under Idaho Code sections 5-402 and 67-5272 because the offices of the Petitioners and Respondent are located, and the matters underlying the Petition arose, in the seat of state government in Boise, Ada County, Idaho.

FACTS AND GENERAL ALLEGATIONS

12. The Idaho State Athletic Commission was established in 1992 under Chapter 4, Title 54, Idaho Code. I.C. § 54-401, et seq. (1992). The duties of the State Athletic Commission include directing, supervising and controlling all amateur and professional contests and exhibitions within the state, with enumerated exceptions. I.C. § 54-406. The State Athletic

Commission has the authority to adopt rules to implement the provisions of Chapter 4 and to implement each of the duties and responsibilities conferred upon it. *Id*.

- 13. Agencies within the Division of Occupational and Professional Licenses, including the State Athletic Commission, adopt administrative rules in accordance with the requirements of the IDAPA. Barron Decl. ¶ 4.
- 14. In 1995, Senate Bill 1254 amended Idaho Code section 67-5224(5) to state that no Fee Rule "shall become effective until it has been approved, amended, or modified by concurrent resolution." 1995 Ida. ALS 196, 1995 Idaho Sess. Laws 196, 1995 Ida. Ch. 196, 1995 Ida. SB 1254.
- 15. From 1995 until 2019, the Legislative Pre-Approval of Fee Rules did not cause undue financial or other hardship to the executive branch because the legislature routinely approved Fee Rules as a matter of course. Barron Decl. ¶ 6.
- 16. In 2016, the Idaho House of Representatives sponsored an amendment to the Idaho Constitution that would enshrine in the Constitution the legislature's ability to review fully promulgated and final administrative rules as set forth in this Court's holding in *Mead v Arnell*, 117 Idaho 660, 791 P.2d 410 (1990). *Idaho Veto-Proof State Legislative Oversight of Administrative Rules and Regulations*, HJR 5 (2016). The Idaho voters approved the amendment, and Section 29 was added to Article III of the Idaho Constitution.
- 17. In 2019, the legislature failed to pass a bill, commonly known as the "going home bill," authorizing all rules currently in effect to be extended for another year. This legislative inaction would have caused the entire Idaho Administrative Code to expire on July 1, 2019 according to the terms of the IDAPA then in effect. I.C. § 67-5292 (2014). To prevent the expiration of the Administrative Code, on June 19, 2019, Governor Brad Little used his

emergency rulemaking authority under Idaho Code section 67-5226 to temporarily reauthorize all administrative rules at great cost to the executive branch. *See* Clark Corbin, *Little Republishes Administrative Rules*, IDAHO EDUCATION NEWS (June 19, 2019), https://www.idahoednews.org/news/little-republishes-administrative-rules/.

- During the 2020, 2021, and 2022 Legislative Sessions, the legislature took no action to approve Petitioners' and others' draft rules. Barron Decl. ¶ 7. This inaction prevented any of the Petitioners' rules from going into effect. Governor Little again used his temporary rulemaking power each of these years to reauthorize administrative rules as temporary. *See Idaho Administrative Bulletin* (April 15, 2020), https://adminrules.idaho.gov/bulletin/2020/04SE.pdf; *see Idaho Administrative Bulletin* (July 21, 2021), https://adminrules.idaho.gov/bulletin/2021/07SE.pdf; *see Idaho Administrative Bulletin* (June 1, 2022), https://adminrules.idaho.gov/bulletin/2022/06.pdf.
- 19. The cost to the executive branch, and specifically to the Division of Occupational and Professional Licenses, resulting from four consecutive years of legislative interference in the administrative rulemaking process was high. For example, in 2021, the cost to republish all administrative rules was \$392,901 statewide, with a cost to the Division of Occupational and Professional Licenses of \$36,051. The subsequent cost of drafting rules in October 2021 was \$369,172 statewide, with a cost to the Division of Occupational and Professional Licenses of \$35,014. The cost of publishing those draft rules was \$365,207 statewide, with a cost to the Division of Occupational and Professional Licenses of \$34,648. In total, the cost of administrative rulemaking in 2021 was \$1,127,280 for the State of Idaho, with costs allocated to the Division of Occupational and Professional Licenses of \$105,713. Ex. A; Barron Decl. ¶¶ 9-10.

- 20. On December 7, 2022, the Division of Occupational and Professional Licenses submitted the State Athletic Commission's draft rules to the Idaho legislature for Legislative Pre-Approval where they were routed to the House and Senate State Affairs Committees for their Legislative Pre-Approval in January of 2023. Barron Decl. ¶ 11.
- 21. On or about March 30, 2023, Lisa Hendricks, the House State Affairs Committee secretary, informed the Division of Occupational and Professional Licenses that the legislature would not "address" the State Athletic Commission's draft rules. Barron Decl. ¶ 12; Ex. B.
- 22. On April 6, 2023, the legislature adjourned *sine die* without approving the State Athletic Commission's rules. Barron Decl. ¶ 13; IDAHO LEGIS. SERV. OFF., THE SINE DIE REPORT 2023 IDAHO STATE LEGISLATURE A SUMMATION OF THE 2023 LEGISLATIVE SESSION, 1st Sess., at 4 (2023).
- 23. Upon adjournment *sine die* of the legislature without Legislative Pre-Approval of the State Athletic Commission's rules, the Rules Coordinator did not publish the rules chapter in the Idaho Administrative Code, and the rules did not become effective. Barron Decl. ¶ 13.
- 24. Effective July 1, 2023, via House Bill 206aaSaaS, the legislature amended the IDAPA to require all administrative rules, not just Fee Rules, to obtain Legislative Pre-Approval before the rules can be published in the Idaho Administrative Code and obtain the force and effect of law. I.C. § 67-5201(11), (19), (21); I.C. § 67-5224(2)(c); I.C. § 67-5291.
- 25. Governor Little refused to sign House Bill 206aaSaaS. On April 6, 2023, Governor Little wrote to the Honorable Mike Moyle, Speaker of the House, stating his objection to the legislature interjecting itself into the executive rulemaking process by conditioning the enforceability of rules on Legislative Pre-Approval. Ex. E.

- 26. On September 15, 2023, the Division of Occupational and Professional Licenses wrote to Respondent demanding that the State Athletic Commission's rules chapter, as submitted on December 7, 2022, be published in the Idaho Administrative Code pursuant to Idaho Code section 67-5204. Ex. C; Barron Decl. ¶ 16. On September 21, 2023, Respondent replied that it would not comply with Petitioner's request because the rules chapter was not approved by the legislature. Ex. D; Barron Decl. ¶ 17.
- 27. As of the date hereof, the State Athletic Commission has no enforceable rules published in the Idaho Administrative Code. Barron Decl. ¶ 18.

CLAIMS FOR RELIEF

I. FIRST CLAIM FOR RELIEF

DECLARATORY RELIEF

- 28. Petitioners re-allege and incorporate by reference as though fully set forth herein paragraphs 1 through 27 above.
- 29. Petitioner's request this Court to exercise its original jurisdiction to declare Legislative Pre-Approval unconstitutional. This Court has exercised free review over questions of constitutional and statutory interpretation when presented with original petitions to settle disputes of a constitutional nature. *See, e.g., Mead,* 117 Idaho 660, 791 P.2d 410 (1990); *Evans v. Andrus,* 124 Idaho 6, 855 P.2d 467 (1993); *Regan v. Denney,* 165 Idaho 15, 437 P.3d 15 (2019).
- 30. The matter is urgent because Respondent has not published the State Athletic Commission's rules in the Idaho Administrative Code, injuring Petitioners by leaving the State Athletic Commission without legally enforceable rules. Barron Decl. ¶ 18; Motion to Expedite p. 2. Respondent's refusal to publish rules without Legislative Pre-Approval has exposed the

Division of Occupational and Professional Licenses to extraordinary and unnecessary expense. Barron Decl. ¶¶ 9-10, 19. Petitioners will continue to be injured in the fast-approaching 2024 Legislative Session in the absence of the relief requested.

- 31. The Idaho Constitution, Article II, Section 1, mandates that the three branches of government, the legislative, executive, and judicial, must remain separate and that one branch may not exercise powers properly belonging to another branch, except as expressly directed or permitted by the constitution.
- 32. By enacting Chapter 4, Title 54 of the Idaho Code, the legislature vested the State Athletic Commission with the authority to adopt administrative rules that have the force and effect of law.
- 33. Promulgation of rules and regulations necessary to implement the purpose of legislative enactments is an executive branch function.
- 34. Conditioning the promulgation and enforceability of administrative rules on Legislative Pre-Approval renders illusory the statutory delegation of authority to promulgate administrative rules pursuant to Chapter 4, Title 54, Idaho Code and prevents the State Athletic Commission from fulfilling its duties and responsibilities.
- 35. Conditioning the promulgation and enforceability of administrative rules on Legislative Pre-Approval is unconstitutional in violation of the separation of powers mandate because it usurps from the executive branch the power to promulgate fully enforceable administrative rules.
- 36. The Idaho Constitution, Article III, Section 29, limits the role of the legislature to reviewing administrative rules only after they have been fully promulgated by administrative

agencies, are published in the Idaho Administrative Code by the Rules Coordinator, and carry the force and effect of law.

- 37. The Idaho Constitution, Article III, Section 29, further limits the legislature's role in reviewing administrative rules to the specific purpose of ensuring the fully promulgated and final rules comply with legislative intent.
- 38. By conditioning the promulgation and enforceability of administrative rules on Legislative Pre-Approval, the legislature attempts to change, through legislation, the meaning and scope of Article III, Section 29, as approved by the Idaho voters.
- 39. The Idaho Constitution, Article III, Sections 1 and 15, requires that the legislature enact laws only by bills passed by a majority vote of each house and that each properly passed law shall contain an enacting clause.
- 40. The Idaho Constitution, Article IV, Section 10, further requires that bills be presented to the Governor to be signed into law or vetoed.
- 41. The legislature's ability to give binding effect of law to its actions is limited by the foregoing provisions of the Idaho Constitution.
- 42. Conditioning the promulgation and enforceability of administrative rules on Legislative Pre-Approval is unconstitutional because Legislative Pre-Approval attempts to employ the informal action of legislative concurrent resolution to give the force and effect of law to rules without an enacting clause and without presentment to the Governor. This action is tantamount to passing new laws without satisfying the bicameralism and presentment requirements of the Idaho Constitution.
 - 43. Petitioners are entitled to a declaratory judgment from this Court that:

- a. Legislative Pre-Approval of administrative rules is not permitted by Article III, Section 29 of the Idaho Constitution.
- b. Legislative Pre-Approval of administrative rules violates the separation of powers mandated by Article II, Section 1 of the Idaho Constitution.
- Legislative Pre-Approval of administrative rules exceeds the legislature's lawmaking authority pursuant to Article III, Sections 1 and 15, and Article IV, Section 10 of the Idaho Constitution.
- d. In remedy, the Petitioners seek a declaration that all Legislative Pre-Approval conditions and requirements of the IDAPA are unconstitutional and unenforceable.

II. SECOND CLAIM FOR RELIEF

WRIT OF MANDAMUS

- 44. Petitioners re-allege and incorporate by reference as though fully set forth herein paragraphs 1 through 43 above.
- 45. This Court has jurisdiction to consider this Petition for issuance of a writ of mandamus. IDAHO CONST. art 5, § 9.
- 46. A writ of mandamus may be granted by this Court to any inferior tribunal, corporation, board or person, to compel the performance of an act which the law especially enjoins as a duty resulting from an office, trust or station." I.C. §§ 7-301, 1-203. A Writ of Mandamus "must be issued in all cases where there is not a plain, speedy and adequate remedy in the ordinary course of law." I.C. § 7-303.

- 47. Respondent has a clear legal duty to publish all administrative rules in the Idaho Administrative Code, and such action is ministerial or executive in nature. I.C. § 67-5204(b); see Coeur D'Alene Tribe v. Denney, 161 Idaho 508, 512, 387 P.3d 761, 765 (2015).
- 48. The Petitioners have no plain, speedy, and adequate remedy at law to protect and preserve the full exercise of their statutory and constitutional duties which Legislative Pre-Approval hinders. If the constitutional issue presented by this Petition were to begin in the District Court, the matter would not be resolved before Petitioners begin drafting administrative rules in November and December 2023 and submitting them to the legislature as required by the Legislative Pre-Approval process before start of the legislative session in January 2024.
- 49. Petitioners have been injured by the Respondent's failure to publish its administrative rules because the State Athletic Commission has no rules that have the force and effect of law, thereby prejudicing its ability to protect the public health, safety and welfare relating to competitions in Idaho. Barron Decl. ¶ 13, 14. The relief requested in this Petition would redress Petitioners' injury because publication in the Idaho Administrative Code gives administrative rules the force and effect of law. I.C. § 67-5204(2)(b).
- 50. This petition concerns matters of statewide importance related to promulgation of statewide agency rules and arises from the fundamental principle of separation of powers as set forth in Article II, Section 1 of the Idaho Constitution.
- 51. The Legislative Pre-Approval requirements of the IDAPA exceed the legislature's authority and violate the Idaho Constitution.
- 52. Petitioners have met all conditions and requirements of the IDAPA other than receiving Legislative Pre-Approval, making the rules final and enforceable and the Rules

Coordinator is required to publish the rules in the Idaho Administrative Code pursuant to Idaho Code section 67-5204(b).

- 53. The Petitioners are entitled to a Writ of Mandamus that compels the Rules Coordinator to:
 - a. Publish the State Athletic Commission's rules chapter, which was drafted in 2022 and submitted to the Rules Coordinator, in the Idaho Administrative Code.

III. THIRD CLAIM FOR RELIEF

EXPEDITED REVIEW

- 54. Petitioners re-allege and incorporate by reference as though fully set forth herein paragraphs 1 through 53 above.
- 55. An expedited review by this Court is requested pursuant to Idaho Appellate Rules 5 and 44 on the grounds that:
 - a. The State Athletic Commission is operating without final rules that have the force and effect of law, due to the Rules Coordinator's refusal to publish the rules in the Idaho Administrative Code, thereby prejudicing the State Athletic Commission's ability to protect the public health, safety and welfare related to unarmed combat events.
 - b. Time is of the essence because each day that passes without enforceable final rules generates the potential of harm to the public and to the participants in amateur and professional contests and exhibitions.
 - c. The 2024 Legislative Session is slated to begin on or about January 8,2024. Historically, review of all agency rules subject to Legislative Pre-

Approval occurs at the outset of the legislative session. It is imperative that all participants in the administrative rulemaking process know their rights and obligations before the legislative session begins.

- d. A later determination of the constitutionality of Legislative Pre-Approval will likely lead to waste of time, money, and resources, and to great governmental inefficiency and uncertainty. 139 executive agency rules are scheduled to be drafted this winter. Each of these rules will be subject to the unconstitutional process of Legislative Pre-Approval in the absence of relief by this Court.
- e. Expedited review and direction from this Court will allow all interested parties to proceed into the 2024 Legislative Session with certainty.

PRAYER FOR RELIEF

Petitioners respectfully request that this Court:

- a) Exercise its original jurisdiction to decide this petition for declaratory relief and mandamus pursuant to Article V, Section 9 of the Idaho Constitution and Idaho Code section 1-203.
- b) Expedite review of this petition for declaratory relief and mandamus.
- c) Expedite any briefing schedule and conduct any hearing the Court may require pursuant to Idaho Appellate Rule 5(d) and 44.
- d) Issue a declaratory ruling as follows:
 - a. That the Legislative Pre-Approval requirements of the IDAPA are unconstitutional in violation of the separation of powers mandate of Article II, Section 1 of the Idaho Constitution and therefore unenforceable.

b. That the Legislative Pre-Approval requirements of the IDAPA, including

conditioning the promulgation and enforceability of administrative rules on

concurrent resolutions of the legislature, are unconstitutional in violation of the

bicameralism and presentment mandates of Article III, Section 15, and Article IV,

Section 10 of the Idaho Constitution and therefore unenforceable.

c. That Article III, Section 29 of the Idaho Constitution does not grant Legislative

Pre-Approval of administrative rules to the legislature, limits legislative review of

administrative rules to rules that have been fully and finally promulgated by

administrative agencies such that they carry the force and effect of law, and

further limits legislative review of administrative rules to ensuring compliance

with legislative intent.

e) Issue a Writ of Mandamus, pursuant to Idaho Code section 7-302, compelling the Rules

Coordinator:

a. To immediately publish the State Athletic Commission's 2023 rules chapter in the

Idaho Administrative Code.

f) Award such other and further relief as the Court deems just and equitable under these

extraordinary circumstances.

RE: Idaho State Athletic Commission Rules

Dear Mr. Hunt,

It has come to the attention of the Division of Occupational and Professional Licenses ("DOPL") that you, as the Administrative Rules Coordinator of the Division of Financial Management ("DFM"), have failed to publish as final in the Administrative Code the rule chapter submitted by DOPL on behalf of the Idaho State Athletic Commission ("SAC") as required by Idaho Code section 67-5204. This letter is a request that you publish the SAC rules as final and effective forthwith.

As you are aware, the Idaho State Constitution, Article II, Section 1 states:

DEPARTMENTS OF GOVERNMENT. The powers of government of this state are divided into three distinct departments, the legislative, executive and judicial; and no person or collection of persons charged with the exercise of powers properly belonging to one of these departments shall exercise any powers properly belonging to either of the others, except as in this constitution expressly directed or permitted.

Furthermore, the Idaho State Constitution, Article III, Section 29 states, in pertinent part:

LEGISLATIVE RESPONSE TO ADMINISTRATIVE RULES. The legislature may review any administrative rule to ensure it is consistent with the legislative intent of the statute that the rule was written to interpret, prescribe, implement or enforce. After that review, the legislature may approve or reject, in whole or in part, any rule as provided by law.

On or about December 7, 2022, DOPL submitted SAC's pending rules to your office for publication in the Administrative Bulletin, as required by Idaho Code 67-5203(4)(b). DFM then submitted SAC's rules to the Legislature, pursuant to the previous version of Idaho Code section 67-5224(5)(c), which required legislative pre-approval of pending fee rules before the rules could become final and effective.

On or about March 30, 2023, Lisa Hendricks, the House State Affairs Committee secretary, informed DOPL that "[the House State Affairs Committee] will not be holding another committee meeting this session. I'm sorry we were not able to address your pending fee rules." On April 6, 2023, the Idaho legislature adjourned sine die without reviewing, approving, or rejecting the SAC rules.

To date, your office has not published SAC's rule chapter, presumably based on the notion that Idaho Code section 67-5224(5)(c) prohibited SAC's rules from becoming final and effective absent pre-approval by the Legislature. However, Idaho Code section 67-5224(5)(c) is unconstitutional, and not controlling, to the extent it requires legislative pre-approval of a proposed rule before it becomes final and effective.

While the Legislature is under no obligation to confer rulemaking authority to the Executive Branch, once it does, rulemaking becomes an Executive Branch function. Under Article II, Section 1, as cited above, the legislature shall not exercise or otherwise prevent the SAC from exercising its statutory obligations and enforcing the law.

In the matter at hand, Idaho Code section 54-406(1) gives SAC the "authority to adopt rules to implement the provisions of this chapter..." Because this duty is specifically allocated to SAC by the Legislature, the promulgation of relevant rules is an Executive Branch function with which the Legislature cannot constitutionally interfere. SAC has met all requirements for rule promulgation as required under the Idaho Administrative Procedures Act.

Article II, Section 1 and Article III, Section 29 of Idaho's Constitution must be read to restrict the Legislature from interfering with or otherwise requiring legislative pre-approval before the Executive Branch can complete the rule promulgation process. Only after the rule becomes final, does the Constitution grant the Legislature the authority to review and reject the rule in whole or in part for its failure to meet legislative intent. Thus, the Legislature's constitutional authority to review administrative rules must be limited only to final rules currently in effect. The Legislature's attempts to condition the effectiveness of a rule on legislative preapproval is unconstitutional.

This issue is even more urgent due to the Legislature's recent expansion of its unconstitutional rules review authority through the passage of 2023 House Bill 206, amending Idaho Code section 67-5201, et seq., which requires all rules be pre-approved by the Legislature before becoming final and effective.

Accordingly, your office must publish SAC's rules as final and effective. Please respond in writing within seven (7) days regarding whether your office intends to publish SAC's rules as requested by this letter.

Dear Mr. Loos,

I am in receipt of your letter dated September 15, 2023 requesting that the Office of the Administrative Rules Coordinator publish as final and effective the administrative rules of the State Athletic Commission ("SAC") as submitted on or about December 7, 2022.

At the outset, the current state of the law presents a serious constitutional question of an urgent nature that should be resolved quickly. In fact, your position is not unique, as evidenced by Governor Little's observation in his signing statement to the Idaho Legislature that "conditioning the enforceability of rules on legislative action runs afoul of constitutional separation of powers and threatens to undermine the negotiated rule making process."

That said, because the SAC's rules were not approved via concurrent resolution my office is bound by statute and thus unable to publish your rule chapter as final. Given that, raising these issues at this time is appropriate. My office is currently assisting agencies with 139 rulemakings that will go before the Idaho Legislature within mere months. Many of these rulemakings make large-scale changes to the entire rule chapter. Additionally, my office will soon begin spending significant time and money compiling the statutorily required legislative review books which contain all rules subject to review by the legislature.

Thank you for reaching out and relaying your concerns about the administrative rules for the SAC. However, we are unable to comply with your request to publish the SAC's rules because they were not approved by the legislature.

Dear Mr. Speaker,

I hereby advise that I have transmitted to the Office of the Secretary of State, without my signature, the following House of Representatives bill, to wit:

House Bill 206aaSaaS

Cutting red tape and making Idaho the least regulated state in the country has been and continues to be one of my administration's major priorities. Through executive orders and other targeted actions, we have eliminated or simplified 95-percent of all administrative rules to ensure Idaho's regulations are streamlined, user-friendly, and easy to understand. I appreciate my legislative colleagues' support of our efforts.

In recent years, unfortunately, misguided provisions in the Idaho Administrative Procedures Act have brought chaos and uncertainty to the rule making process that has caused unnecessary costs to taxpayers and undermined the hard work the public and regulated community have dedicated toward negotiating better rules. I welcome legislative efforts to address these concerns; however, my support of House Bill 206aaSaa is mixed.

I applaud the Legislature's action in Section 8 of the bill. Repealing the need for a "going home bill" each year will save taxpayers money and provide Idahoans with the level of certainty they deserve. I also support the Legislature's commitment to review all administrative rules every eight years, codifying the requirement I imposed on all executive agencies in Executive Order No. 2020-01, Zero-Based Regulation.

On the other hand, I cannot support various amendments in Sections 1, 4, and 7 that interject the Legislature into the executive rulemaking process by requiring legislative preapproval of rules before they take effect. By way of Article III, Section 29, of the Idaho Constitution, the Legislature has constitutional authority to review administrative rules that carry the force and effect of law to ensure those rules are consistent with legislative intent.

Conditioning the enforceability of rules on legislative action runs afoul of constitutional separation of powers and threatens to undermine the negotiated rule making process.

During my time as Governor, Idaho has led the nation in cutting red tape. Our track record in reducing regulatory burden is second to none. In 2016, Idahoans voted to protect our regulatory process, known as rulemaking, by putting it in our Idaho Constitution and preserving Legislative review of final rules that agencies have put into effect. I find provisions in House Bill 206aaSaaS to run counter to what Idahoans voted for while adding friction to a process that has allowed us to become the least regulated state in the country.
